Digital Constitutionalism and the UN Global Digital Compact

Outline

This Blended Intensive Program (BIP) is organized by the [Digital Constitutionalism Network](#) (DCN) and offers students from different European universities an opportunity to come together, both virtually and in person, to discuss issues pertaining to digital developments and related global policy development processes. The BIP is part of a teaching partnership that the DCN has promoted since 2019. The 2024 BIP follows upon a successful BIP organized at the University of Padova in 2023. The BIP continues to engage participants in a transdisciplinary way, with a focus on theories and methods from legal studies, media and communication, and political science.

The 2024 BIP is dedicated to exploring the intersections between *Digital Constitutionalism and the UN Global Digital Compact*. It aims at providing students with the theoretical, analytical and methodological tools to make sense of the values and principles that (should) guide regulatory arrangements for the digital age, including those proposed in the consultation process for the UN's Global Digital Compact due to be agreed at the September 2024 Summit of the Future.

The 2024 BIP includes two components - one online and one offline - during which students will explore a range of issues related to digital constitutionalism and the UN Global Digital Compact. The program will also provide participants transversal skills, including: public speaking, group work, intercultural competences and the know-how needed for effective interventions in digital governance such as policy brief writing skills.

The common policy-oriented research project, on which students will work on in small teams, focuses on research tasks related to the Global Digital Compact, specifically the influences that went into its (ongoing) formulation between UN member states. Here, the consultation process allows for a multi-method inquiry of a highly current topic that concerns scholars, policymakers, activists and citizens the world over. In addition to publicly available materials from the consultations, students could also conduct interviews. Students will also make use of the DCN database of 321 digital bills of rights published over the past thirty years, in order to better understand the path toward the UN Global Digital Compact.

Basic information

- Interdisciplinary approach, with a focus on law, political and communication sciences
- Up to 25 students in mobility from seven core partners: University of Padova, University of Salerno, Dublin City University, University of Groningen, Tallinn University, University of Klagenfurt and University of Helsinki

- Open call for up to 5 students from YUFE universities
- Up to 10 Students from the University of Bremen
- 6 ECTS credits recognized for the activity; students receive a certificate of participation
- MA-level at host institution (incoming BA students welcomed)
- Virtual component: 8 hours, 4 hours each before and after mobility
- In-person component: 30 hours, Bremen, 22-26 April 2024

Learning Objectives

- Gain knowledge about **scholarly discourses** concerning the rights-based governance of digital technologies, specifically the Internet and artificial intelligence
- Understand **digital constitutionalism** as an interdisciplinary concept that relates to advocacy and rulemaking within Internet and digital governance
- Understand the context and the debates around the **UN Global Digital Compact (GDC)**
- Practice to **think critically** about the effectiveness of digital constitutionalism for the realization of social goods and the protection of human rights in the context of the GDC
- Gain **research and writing experience** at the nexus of human rights and the digital
- Learn in a **transnational** European context, and practice to use **blended learning** formats for your own learning process
- Gain **transversal skills**, including public speaking and group work skills, intercultural competences and the know-how needed for effective interventions in digital governance such as policy brief writing skills.

Assessment

The assessment of the BIP consists of the final group presentation in Bremen (26 April) and a jointly written, research-based policy brief to be handed in on 24 May (draft policy briefs due on 17 May).
